Guidelines for Registration

- All families must complete drafting information (ACH Form)
- Registration is complete and the Early Learners space is secured when:
 - Registration form is completed and returned to the school
 - Registration fee (non-refundable and non-transferable) of \$195 is paid.
 - Auto Draft form is complete
 - A copy of Birth Certificate (long form) is provided for the office
 - A copy of SC Immunization form is provided for the office

Registration Reminders

- A registration fee is due at the time of submitting the registration documents.
- Registration is for the 2022-2023 school year only
- In the event your child will not be able to attend, please notify the school office as soon as possible. All paid registration fees are non-refundable.
- Re-enrollment is required for each new school year.

Early Learners (Daycare) Important Information

- The Academy Early Learners program is open from 7:30 am-6:00 pm, Monday through Friday.
- The Academy will publish a calendar for the Early Learners school year. The Administration reserves the right to make changes to the calendar and will communicate those in a timely fashion if changes are necessary.
- Our goal is to provide a safe, nurturing, developmentally appropriate environment for your Early Learner. Our focus in each classroom is a developmental focus and considers that God created us to grow and develop at different rates. We recognize that our students are fearfully and wonderfully made.

Withdrawal Policy

Enrollment at Mauldin Christian Academy is a partnership between MCA and the parents and a commitment for the entire school year for the entire tuition amount. On some occasions, it may be necessary to withdraw your student from MCA. If this is the case, we ask that parents give a written notice at least two weeks' notice in advance. If less than two weeks' notice is given, parents/guardians will be charged the tuition fee for two weeks past the notice of withdrawal.

WE AGREE that we will support and do pledge our full cooperation to the school’s mission, policies, and practices and goals as presented in the MCA Student Handbook.

WE AGREE we will work together with MCA administrators, teachers, and staff in encouraging our child to follow Biblical teachings and high academic standards.

WE UNDERSTAND that MCA is a Christian school, and my child will be taught subjects from a Biblical worldview as well as receive daily Bible instruction.

WE UNDERSTAND that our child will be encouraged to perform to the best of their ability academically and in all other endeavors.

WE UNDERSTAND and support the school’s policies in disciplining MCA students. This will include appropriate consequences, redirection, and positive reinforcement for Christ like behaviors.

FINANCIAL POLICY AGREEMENT

WE AGREE to complete our financial responsibilities as established in the MCA Tuition and Fee Schedule in a timely manner and to honor the payment plan indicated by our selection in the Auto-Draft Agreement.

WE AGREE that enrollment at MCA is a full year commitment to attendance and tuition responsibility.

WE UNDERSTAND that all fees including application, enrollment, or re-enrollment fees are **non-refundable**.

WE UNDERSTAND that:

- MONTHLY payments will auto draft on the first Friday of each month, August through May.
- WEEKLY payments will begin the first week of school and continue for 42 consecutive weeks (Preschool half-days and K5-5th) 51 weeks for Early Learner daycare.
- TUITION paid in full by August 1st will receive a 5% discount.
- ANNUAL tuition is divided into equal monthly payments regardless of holidays or number of days in a month.

WE UNDERSTAND if my tuition draft is returned, a \$30 fee will be added to my account.

WE UNDERSTAND we are required to pay the curriculum and technology fee charged in June, July, and August. (K5-5th grade)

WE UNDERSTAND that if our account is delinquent by one month, arrangements to bring the account current must be made with the business office.

WE UNDERSTAND that if our account is delinquent by two months, services may be terminated immediately.

WE UNDERSTAND that past due balances will accrue a 5% late fee charge.

WE UNDERSTAND that I am required to give a WRITTEN NOTICE of at least ONE MONTH prior to my child's last day at MCA. If less than one month's notice is given, I understand I will be charged one month's tuition from the date of notice.

Mauldin Christian Academy Statement of Faith

As a Christian educational organization and a ministry of Mauldin First Baptist Church, Mauldin Christian Academy (MCA), embraces the Old and New Testament, and believe they are inspired by God and are of supreme and final authority in faith, standards of education, and our guide for all areas of living. (Isaiah 40:8; 2 Timothy 3:16-17; 2 Peter 1:21).

- We believe the Bible is the inspired Word of God and is the ultimate authority in our lives. (2 Timothy 3:16, 2 Peter 1:21).
- We believe there is one God, eternally existent in three persons-Father, Son, and Holy Spirit (Genesis 1:1, Matthew 28:19, John 10:30).
- We believe in the deity of Christ (John 10:33), His virgin birth (Isaiah 7:14, Matthew 1:23, Luke 1:35), His sinless life (Hebrews 4: 15, 7:26), His miracles (John 2:11), His death on the cross (1 Corinthians 15:3, Ephesians 1:7, Hebrews 2:9), and His Resurrection (John 11:25, 1 Corinthians 15:4), His Ascension to the right hand of God (Mark 16:19), His personal return in power and glory (Acts 1:11, Revelation 19:11).
